Frequently Asked Questions about the Electronic Giving Program

| <p>Q. What is the Electronic Giving Program? A. An automatic program of making contributions without writing checks.</p> | <p>Q. When will my contribution be deducted from my account? A. On the date you authorize. The church will process a test transaction for each new enrollment at least 10 days before the first authorized contribution; however, this will have no effect on your bank account balance.</p> | <p>Q. What do I do if I change bank accounts or if I decide I don't like the program? A. Call the church office, and we will provide you with a new enrollment form for any changes, including canceling your enrollment.</p> |
| <p>Q. What are the advantages of participating in the Electronic Giving Program? A. The program eliminates the cost of processing checks for the donor and the church, provides a way for the donor to make contributions even when out-of-town, eases seasonal cash flow problems for the church, and enhances security of donations to the church.</p> | <p>Q. How do I balance my checkbook or prove I made my contribution? A. As your contribution is made at a pre-established time, simply record it in your check register. Your bank statement will also give you an itemized list of your electronic transfers, and the church will continue to provide you with a giving statement.</p> | <p>Q. What is the cost for participating in the electronic giving program? A. Donors will incur no fees. The church may pay a small transaction fee for each donation.</p> |
| <p>Q. How is my contribution deducted from my account? A. Once you complete an enrollment form to authorize the transfer, your contribution is transferred directly from your account to the church's account.</p> | <p>Q. Will my contribution be safe? A. Yes, because contributions are processed through the Automated Clearing House (ACH) of the Federal Reserve system, your contribution is more secure than a cash or check contribution.</p> | <p>Q. How do I sign up for the electronic giving program? A. Complete this enrollment form and return it to the church office along with a voided check or voided savings deposit slip.</p> |
